1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
11 **approving applicants for membership contain misspellings in the names of**  
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 15-80, 46-**  
14 **80, 114-80, 115-82, 136-82, 150-82, 16-83, 184-83, 184-84, 97-256, 97-460, 98-034,**  
15 **98-123, 98-174, 98-429, 98-357, 99-004, 99-140, 99-200, 99-311, 99-360, 99-420, 99-**  
16 **633, 2000-035, 01-133, 02-003, 02-074, 02-369, 05-114, 05-148, 06-059, 11-402, 12-**


