4		funding level shall be submitted for further prior approval by the legislative
5		council; and
6	WHEREAS,	the San Lucy District Council approved Resolution No. SL 7-59-15, "Approving
7		San Lucy District Maintenance Program FY 2015 Budget Amendment No. 1"
8		reduces \$25,000.00 from line item 610 Salaries and that amount is
9		reapportioned within the Maintenance department Operations Budget to cover
10		anticipated expenses to the end of the budget cycle, which also includes the
11		decrease of 712 Gas, Oil, Lube, in amount of \$5,000.00 and increase 721 Supplies-
12		Other in amount of \$5,000.00; and
13	WHEREAS,	the San Lucy District - Maintenance Program FY 2015 aggregate budget total
14		remains at \$299,363.24 wherein, the Maintenance Program operational budget
15		is increased from \$102,550.52 to \$127,550.52; and
16	WHEREAS,	the Budget and Finance Committee of the Legislative Council have reviewed and
17		recommends its approval.
18	NOW, THERE	FORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves
19		San Lucy District - Maintenance Program FY 2015 Budget Amendment No. 1,
20		Whereby, \$25,000.00 from line item 610 is reapportioned to the Maintenance
21		Program Operations Budget to pay anticipated expenses to the end of the budget
22		cycle, in accordance with the attached budget.
23	BE IT FINALI	Y RESOLVED the Tohono O'odham Legislative Council hereby authorizes the San
24		Lucy District Chairperson and any other designated District official to expend
25		and administer the budget as attached, provided that any
26		amendments/modifications affecting the funds or funding level shall be
27		submitted for further prior approval by the Tohono O'odham Legislative
28		Council.
