6		District Allocation Guidelines through Fiscal Year 2017 per resolution 14-345;

8	WHEREAS,	the Nation approved Resolution No. 15-164 to approve the FY2016 Revenue
9		Projection in the amount of \$73,704,604.00; and
10	WHEREAS,	the Nation's Treasurer proposed amendments to the revenue projection based
11		on updated financial information; and
12	WHEREAS,	the overall revenue projection total of \$73,704,604.00 has not changed; and
13	WHEREAS,	the Legislative Budget and Finance Committee and the Executive Office
14		reviewed the amended revenue projections for FY 2016; and
15	WHEREAS,	the Budget and Finance Committee, and the Executive Office recommend the
16		adoption of the amended FY 2016 revenue projections in the amount of
17		\$73,704,604.00 to fund the FY2016 General Fund Budgets per the attached FY
18		2016 Revenue Projections.
