## **RESOLUTION NO. 15-352**

1	WHEREAS,	the Tohono O'odham and their ancestors, the Archaic and Hohokam peoples
2		have inhabited Southern Arizona since time immemorial; and
3	WHEREAS,	the Tohono O'odham Nation recognizes the need to protect, preserve, and
4		manage cultural resources on its traditional lands; and
5	WHEREAS,	the Native American Graves Protection and Repatriation Act of 1990 (NAGPRA) 25
6		U.S.C.: 3001-3013) and 43 C.F.R.: 10.2(b) provides definitions and procedures for
7		the repatriation of certain Native American human remains and cultural items,
8		as defined in 25 U.S.C. :3001-3013, in the possession of federal agencies and
9		museums that receive federal funds to lineal descendants, Indian tribes and
10		Native Hawaiian organizations; and
11	WHEREAS,	the Cultural Affairs Office of the Tohono O'odham Nation has been consulting
12		with the Arizona State Museum at the University of Arizona for the return of
13		these NAGPRA items on the attached list; and
14	WHEREAS,	the University of Arizona-Arizona State Museum has recently received a NAGPRA
15		grant from the National Park Service to assist in the preparation of the NAGPRA
16		items on the attached list for return to the Tohono O'odham Nation; and
17	WHEREAS,	the Cultural Preservation Committee of the Tohono O'odham Nation's
18		Legislative Council has reviewed and approved the Transfer of Control
19		Agreement; and
20	WHEREAS,	the Attorney General's Office of the Tohono O'odham Nation has reviewed and
21		approved the Transfer of Control Agreement.
22	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
23		approves the Transfer of Control Agreement with the University of Arizona to
24		return NAGPRA items to the Tohono O'odham Nation and authorizes the
25	:	Chairman of the Tohono O'odham nation to sign the Transfer of Control
26		Agreement with the University of Arizona.
