## LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Designating the September 18, 2015 General Session at Vee Quiva Hotel and Casino for the Arizona Indian Gaming Association Meeting)

**LEGISLATIVE ORDER NO. 15-353** 

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and 2 procedures to regulate all meetings of the Tohono O'odham Council, standing 3 committees, boards and special committees." (Constitution of the Tohono 4 O'odham Nation, Article VI, Section 1(a)); and Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative 5 WHEREAS, Council, as amended, provides that "[a]ll Legislative Council sessions shall be 6 7 held at the Tohono O'odham Legislative Council chambers located in Sells, 8 Tohono O'odham Nation, with the following exceptions. . .
