

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Designating the September 18, 2015 General Session at Vee Quiva Hotel and
Casino for the Arizona Indian Gaming Association Meeting)

LEGISLATIVE ORDER NO. 15-353

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative**
6 **Council, as amended, provides that "[a]ll Legislative Council sessions shall be**
7 **held at the Tohono O'odham Legislative Council chambers located in Sells,**
8 **Tohono O'odham Nation, with the following exceptions. . . [a] majority of all the**
9 **legislative representatives may vote to hold a session in some location other**
10 **than the chambers located at Sells."; and**

11 **WHEREAS, the Commerce Committee has requested the Legislative Council designate the**
12 **September 18, 2015 general session at Vee Quiva Hotel and Casino for the**
13 **Arizona Indian Gaming Association meeting.**

14 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it**
15 **designates the September 18, 2015 general session at Vee Quiva Hotel and**
16 **Casino for the Arizona Indian Gaming Association meeting and roll call shall be**
17 **taken at 8:30 a.m.**


18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 15TH day of**

20 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
21 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
24 **June 18, 1934 (48 Stat.984).**
