

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting September 21, 2015 Special Session to Address Fiscal Year 2016 District Budgets)**

LEGISLATIVE ORDER NO. 15-354

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**
6 **Council with the authority to "by majority vote, call for a special session"**
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**
8 **1.D.1.); and**

9 **WHEREAS, the Budget and Finance Committee has requested a special session on**
10 **September 21, 2015 to address Fiscal Year 2016 district budgets.**

11 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**
12 **special session on September 21, 2015 to address Fiscal Year 2016 district**
13 **budgets.**

14 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 15TH day of**
15 **SEPTEMBER, 2015 at a meeting at which a quorum was present with a vote of 2,896.1 FOR; 125.3**
16 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
17 **Article VI, Section 1(a) and 1(d) of the Constitution of the Tohono O'odham Nation, adopted by**
18 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
20 **June 18, 1934 (48 Stat.984).**
