RESOLUTION NO. 15-355

1 **WHEREAS, the Department of Health and Human Services, Management of Health Division**
2 **coordinates services provision for its divisions; and**

3 **WHEREAS, the Domestic Violence Program is housed under the Management of Health-**
4 **Prevention Division; and**

5 **WHEREAS, the Domestic Violence Program is to educate the community on prevention of**
6 **domestic violence, dating violence, sexual assault and stalking; and**

7 **WHEREAS, the Tohono O'odham Department of Health & Human Services, Division of**
8 **Prevention Kom Ckud Ki: Domestic Violence Program submitted a proposal and**
9 **was selected to be a recipient of the Desert Diamond Casino & Entertainment**
10 **12th Annual Golf Tournament award; and**

11 **WHEREAS, a check was presented on June 11, 2015 in the amount of \$44,450.00 to the Kom**
12 **Ckud Ki: Domestic Violence Program to be utilized by the program for**
13 **training/educating the community; and**

14 **WHEREAS, the Kom Ckud Ki: Domestic Violence Program will utilize the funds between July**
15 **31, 2015 and December 24, 2015; and**

16 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
17 **Legislative Council have reviewed FY 2015 - FY 2016 Health & Human Services**
18 **Kom Ckud Ki: Domestic Violence Program Budget and recommends its**
19 **approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 21 **1.) Accepts and approves the Desert Diamond Casino & Entertainment 12th**
22 **Annual Golf Tournament award in the amount of \$44,450.00.**
- 23 **2.) Approves and authorizes expenditure of the FY 2015 - FY 2016 Health &**
24 **Human Services Kom Ckud Ki: Domestic Violence Program Budget for**
25 **the purpose of training/educating the community.**
- 26 **3.) Authorizes funds to be utilized beginning July 31, 2015 and ending**
27 **December 24, 2015 as long as it meets the purpose and intent of the**
28 **funding.**

12 **the Act of June 18, 1934 (48 Stat.984).**




