

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting and Approving First Things First Grant No. GRA-RC026-16-0770-01 and**  
**the FY 2016 First Things First Budget in the Amount of \$150,000.00)**

**RESOLUTION NO. 15-356**

1 **WHEREAS, the First Things First Tohono O'odham Nation Regional Council has awarded**  
2 **funds to the Tohono O'odham Nation Division of Early Childhood Development;**  
3 **and**

4 **WHEREAS, the Tohono O'odham Nation has operated and continues to operate early**  
5 **childhood education services to provide educational, health, mental health and**  
6 **parent involvement services to children, three to five years of age; and**

7 **WHEREAS, the First Things First Tohono O'odham Nation Regional Council has awarded the**  
8 **Tohono O'odham Nation Division of Early Childhood Development an amount of**  
9 **\$150,000.00; and**

10 **WHEREAS, the FY 2016 First Things First Intergovernmental Agreement (IGA) GRA-RC026-**  
11 **16-0771-01 was approved by Resolution No. 15-258; and**

12 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**  
13 **the Tohono O'odham Legislative Council have reviewed the budget and**  
14 **recommend its approval; and**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
16 **accepts and approves the First Things First Grant No. GRA-RC026-16-0770-01 and**  
17 **the FY 2016 First Things First Budget in the Amount of \$150,000.00 to be effective**  
18 **July 1, 2015 through June 30, 2016 and request authorization to expend funds**  
19 **and to utilize the Nation's resources pending reimbursement from the grantor**  
20 **for the continuation of the grant.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
22 **Chairperson and any designated official to expend and administer the budget as**  
23 **attached, provided that any amendments affecting the funds or funding level is**  
24 **submitted for further prior approval by the Tohono O'odham Legislative**  
25 **Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
27 **day of SEPTEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4**  
28 **FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the**  
29 **Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted**  
30 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
31 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**  
32 **the Act of June 18, 1934 (48 Stat.984).**




