1 **WHEREAS, the Tohono O'odham Nation was awarded the Department of Justice (DOJ),**
2 **Office of Justice Program (OJP), Office of Juvenile Justice and Delinquency**
3 **Prevention (OJJDP), Youth Mentoring Program, grant no. 2011-TX-FX-0010; and**

4 **WHEREAS, the grant was accepted by the Tohono O'odham Legislative Council by**
5 **Resolution No. 11-541; and**

6 **WHEREAS, the grant dates were from October 1, 2011 to September 30, 2014; and**

7 **WHEREAS, the Tohono O'odham Nation requested a 12 month No Cost Extension, changing**
8 **project end date to September 30, 2015, which was accepted by TOLC resolution**
9 **No. 14-476; and**

10 **WHEREAS, the Tohono O'odham Nation requested a second 12 month No Cost Extension**
11 **from DOJ/OJJP changing Project end date to September 30, 2016 and was**
12 **approved; and**

13 **WHEREAS, a FY 2016 budget has been prepared and submitted for approval; and**

14 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees of the Legislative**
15 **Council have reviewed this Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
17 **accepts the 12 month No Cost Extension for the DOJ, OJP, OJJDP, Youth**
18 **Mentoring Program, grant no. 2011-TX-FX-0010 and approves the attached FY**
19 **2016 budget in the amount of \$137,995, with effective dates of October 1, 2015**
20 **through September 30, 2016.**

21 **BE IF FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
22 **the Chairperson and any designated official to expend and administer the**
23 **budget as attached, provided that any amendments affecting the funds or**
24 **funding level shall be submitted for further prior approval by the Tohono**
25 **O'odham Legislative Council.**




