

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 14-566 to Dedicate Funds from the Settlement Agreement
with the Indian Health Service Regarding Contract Support Costs)**

RESOLUTION NO. 15-364

1 **WHEREAS,** by Resolution No. 14-566 the Tohono O'odham Nation ("Nation") agreed to a
2 settlement with the Indian Health Service to settle claims for Contract Support
3 Costs incurred in fiscal year 2006-2010 in the amount of \$530,000; and

4 **WHEREAS,** the settlement amount increased to \$555,798.71 due to added interest, and was
5 paid to the Nation in July 2015; and

6 **WHEREAS,** the Nation has utilized \$144,000 of that amount to fund the attorney contract
7 with the law firm of Sonosky Chambers Sachse Miller & Munson, LLP, leaving a
8 remainder of \$411,798.71; and

9 **WHEREAS,** it is in the Nation's best interest to dedicate the remainder of the Indian Health
10 Service settlement identified above to future costs related to negotiating and
11 implementing a self-governance compact with the Indian Health Service for
12 operation of the Sells Service Unit; and

13 **WHEREAS,** this matter has been reviewed by the Health and Human Services and the Budget
14 and Finance Committees, which recommend approval by the Legislative
15 Council.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council amends
17 Resolution No. 14-566 to add the following additional Resolved clause:

18 ***BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council*
19 ***dedicates the settlement funds derived from the Settlement Agreement with the***
20 ***Indian Health Service on Contract Support Costs from fiscal years 2006 through***
21 ***2010 to the Nation's efforts to assume the program, functions, services and***
22 ***activities currently performed by the Indian Health Service for the benefit of the***
23 ***Nation.***

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**
25 **day of SEPTEMBER, 2015** at a meeting at which a quorum was present with a vote of **3,021,4**
26 **FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT,** pursuant to the powers vested in the
27 **Council by Article VI, Section 1(c)(2)and(f) of the Constitution of the Tohono O'odham Nation,**
28 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
30 **16 of the Act of June 18, 1934 (48 Stat.984).**
