

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2015 - FY 2016 Veterans Affairs Supplemental Budget)

RESOLUTION NO. 15-368

1 **WHEREAS, the Tohono O'odham Veterans were assigned land in Sells, Arizona per Tohono**
2 **O'odham Council Resolution No. 06-749 located across from the Indian Oasis**
3 **Elementary School, along Main Street to build a Veterans Memorial Park; and**

4 **WHEREAS, the Tohono O'odham Nation had received a grant of \$50,000 from U. S.**
5 **Department of Housing and Urban Development to begin the construction of the**
6 **Memorial Park; and**

7 **WHEREAS, the Veterans Affairs Office applied for and was awarded a 3 year Sponsorship in**
8 **the amount of \$44,450.00 from Desert Diamond Casino & Entertainment 12th**
9 **Annual Golf Tournament to continue the development of the Memorial Park,**
10 **and for Education/Training; and**

11 **WHEREAS, the Veterans Affairs Office has prepared a FY 2015 Budget as attached utilizing**
12 **\$44,148.66 of the \$44,450.00 donation award with a remaining amount of \$301.34**
13 **to be utilized at a later date; and**

14 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**
15 **the Legislative Council have reviewed the budget and recommends its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 17 **1. Approves the FY 2015 - FY 2016 Veterans Affairs Supplemental Budget.**
- 18 **2. Authorizes funds to be utilized beginning July 31, 2015 and ending December**
19 **24, 2015 as long as it meets the purpose and intent of the funding.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the Budget as**
22 **attached, provided that any Amendments affecting the funds or funding level is**
23 **submitted for further prior approval by the Tohono O'odham Legislative**
24 **Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**
26 **day of SEPTEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4**
27 **FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
28 **Council by Article VI, Section 1(d)(2)and(3)of the Constitution of the Tohono O'odham Nation,**
29 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
31 **16 of the Act of June 18, 1934 (48 Stat.984).**
