1 **WHEREAS, the Tohono O'odham Legislative Council his historically supported the Venito**
2 **Garcia Library, the primary agency for the Tohono O'odham Nation; and**

3 **WHEREAS, the Venito Garcia Library is charged with library development for the Tohono**
4 **O'odham Nation; and**

5 **WHEREAS, the Venito Garcia Library under the Tohono O'odham Nation Education**
6 **Department has applied for and received the Basic Library Services Grant from**
7 **Institute of Museum and Library Services (IMLS), Native American Library**
8 **Services (NALS) who is the primary library funding agency from the United States**
9 **federal government; and**

10 **WHEREAS, the Venito Garcia Library is submitting and FY 2016 IMLS Basic Grant Budget in**
11 **the amount of \$7,000.00; and**

12 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**
13 **the Tohono O'odham Legislative Council have reviewed this budget and**
14 **recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **approve and accept the grant funds and budget for the Venito Garcia Library**
17 **Institute of Museum and Library Services (IMLS), Native American Library**
18 **Services (NALS) and approve the FY 2016 IMLS Basic Grant Budget in the amount**
19 **of \$7,000.00.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding level is**
23 **submitted for further prior approval by the Tohono O'odham Legislative**
24 **Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**
26 **day of SEPTEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4**

28 **Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted**

30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
31 **the Act of June 18, 1934 (48 Stat.984).**
