

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Tohono O'odham Judicial Branch Budget Amendment #1)**

RESOLUTION NO. 15-370

1 **WHEREAS, the Tohono O'odham Legislative Council approved FY 2016 Judicial Branch**
2 **Budget Resolution No. 15-169 at \$5,835,586.12; and**

3 **WHEREAS, the FY2016 tribal budget included 20 furlough days and the 638 budget included**
4 **18 furlough days for the employees; and**

5 **WHEREAS, the Budget and Finance Committee had inquired whether we had looked at**
6 **other alternatives to the furlough days; and**

7 **WHEREAS, the cost to cover the furlough days for all tribal and 638 employees is**
8 **\$382,614.42; and**

9 **WHEREAS, in FY2015, the Judicial Branch had vacancies throughout the year which as of**
10 **June 26, 2015 will result in unused funds in the amount of \$423,762.14; and**

11 **WHEREAS, the Judicial Branch is requesting that funds from the FY2015 budget in the**
12 **amount of \$382,614.42 be forwarded to the FY2016 budget to cover the furlough**
13 **days; and**

14 **WHEREAS, the Judicial Branch has prepared the attached Budget Amendment #1 to reflect**
15 **the changes listed above for a total budget of \$6,218,200.54; and**

16 **WHEREAS, the Legislative Judiciary and the Budget and Finance Committees have reviewed**
17 **this budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves**
19 **the attached FY 2016 Tohono O'odham Judicial Branch Budget Amendment #1**
20 **for a total budget of \$6,218,200.54.**


21 **BE IT FURTHER RESOLVED that funds from the FY2015 budget in the amount of \$382,614.42**
22 **will be forwarded to the FY2016 budget to cover the furlough days.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chief Judge and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding level**
26 **shall be submitted for further prior approval by the Tohono O'odham**
27 **Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH day of SEPTEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).




