

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2016 Pisinemo District Supplemental Budget)**

RESOLUTION NO. 15-379

1 **WHEREAS, the Tohono O'odham Nation Legislative Council did pass Resolution #15-275 for**
2 **"Implementing Initiative No. INT-01-14, "Dissolution of the Hia Ced District and**
3 **Distributing Funds to Nation's Districts" for an equal distribution to the Nation's**
4 **eleven Districts for an amount of \$126,260.07; and**

5 **WHEREAS, on August 31, 2015, the Pisinemo District Council approved Resolution 15-P-37**
6 **for a budget in the amount of \$126,260.07 from Initiative INT-01-14 Distribution;**
7 **and**

8 **WHEREAS, Pisinemo District Council Resolution No. 15-P-37 also approved carryover of**
9 **FY14 Mining Royalty & Bank of America Savings in the amount of \$4,878.62; and**

10 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did**
11 **review the budget and recommend its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve the Fiscal Year 2016 Pisinemo District Supplemental Budget from**
14 **Initiative INT-01-14 Distribution in the amount of \$126,260.07 and carryover of**
15 **FY14 Mining Royalty & Bank of America Savings in the amount of \$4,878.62 for a**
16 **total budget of \$131,138.69 as attached hereto.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **District Chairperson and any designated official to expend and administer the**
19 **Budget as attached, provided that any modifications/amendments affecting the**
20 **funds or funding level is submitted for further prior approval by the Tohono**
21 **O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
23 **day of SEPTEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021,4**
24 **FOR; -0- AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the**
25 **Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**
26 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
27 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
28 **16 of the Act of June 18, 1934 (48 Stat.984).**


