**RESOLUTION NO. 15-381**

1 **WHEREAS, Tohono O'odham Legislative Council approved FY 2016 District Allocation and**  
2 **Apportionment of Gaming Revenues to Districts by Equal distributions in an**  
3 **amount of \$4,718,212.23; and**

4 **WHEREAS, the District is requesting their apportionment of the distribution of funds from**  
5 **Resolution #15-275 passed by the Tohono O'odham Legislative Council**  
6 ***"Implementing Initiative No. INT-01-14, "Dissolution of the Hia Ced District and***  
7 ***Distributing Funds to Nation's Districts"* for an equal distribution to the Nation's**  
8 **eleven Districts for an amount of \$126,260.07; and**

9 **WHEREAS, the District is requesting release of \$29,634.61 held by the U.S. Department of**  
10 **the Interior Office of the Special Trustee (OST) from the Asarco Mine Lease; and**

11 **WHEREAS, the District will utilize a total of \$2,146,796.41 of the District Investment Funds**  
12 **to cover the remaining amount of the overall district budgeted amount of**  
13 **\$7,020,903.32; and**

14 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**  
15 **did review the budget and recommends its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
17 **approve the San Xavier District FY2016 Budget utilizing Gaming Revenues in an**  
18 **amount of \$4,718,212.23, Monies Held by the U.S. Department of the Interior**  
19 **Office of the Special Trustee (OST) in the amount of \$29,634.61, Hia Ced District's**  
20 **Dissolution Distribution in the amount of \$126,260.07 and \$2,146,796.41 of the**  
21 **Districts Investment Funds in the budget as attached hereto, totaling**  
22 **\$7,020,903.32.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **District Chairperson and any designated official to expend and administer the**  
25 **Budget as attached, provided that any modifications/amendments affecting the**  
26 **funds or funding level is submitted for further prior approval by the Tohono**  
27 **O'odham Legislative Council.**
