

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Schuk Toak District Budgets with FY 2016 Gaming
Allocation, FY 2014 Carry Forward Funds and INT-01-14 Funds)**

RESOLUTION NO. 15-382

1 **WHEREAS, Tohono O'dham Legislative Council approved FY 2016 District Allocation and**
2 **Apportionment of Gaming Revenues to Districts by Equal distributions of which**
3 **\$1,615,811.13 was allocated to Schuk Toak District; and**

4 **WHEREAS, Schuk Toak District is requesting their apportionment of the distribution of**
5 **funds from Resolution #15-275 passed by the Tohono O'odham Nation**
6 **Legislative Council "Implementing Initiative No. INT-01-14, "Dissolution of the**
7 **Hia Ced District and Distributing Funds to Nation's Districts" for an equal**
8 **distribution to the Nation's eleven Districts for an amount of \$126,260.07; and**

9 **WHEREAS, the Schuk Toak District will also be utilizing FY 2014 Carry Forward in the**
10 **amount of \$2,577,014.57; and**

11 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**
12 **did review the budget and recommends its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
14 **approves the FY 2016 Schuk Toak District Budgets of FY 2016 Gaming Allocation**
15 **of \$1,615,811.13, FY 2014 Carry Forward Funds of \$2,577,014.57 and INT-01-14**
16 **Funds of \$126,260.07 for a total overall amount of \$4,319,085.80 which is**
17 **budgeted as follows:**
