

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2016 Sif-Oidak District Budget in the amount of \$1,975,363.29)**

**RESOLUTION NO. 15-384**

1 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 15-325,**  
2 **"Approving FY 2016 District Allocation and Apportionment of Gaming Revenues**  
3 **to Districts by Equal Distribution"; and**

4 **WHEREAS, the apportionment for the Sif-Oidak District is in the amount of \$1,615,811.13**  
5 **and is made available for expenditure subject to an approved budget in**  
6 **accordance with Article VI, Section 1(d)(2) and Article IX, Section 7 of the**  
7 **Nation's Constitution; and**

8 **WHEREAS, the Sif-Oidak District Council, on September 12, 2015 passed Resolution No.**  
9 **SODC 15-158, "Approving the FY 2016 Sif-Oidak District Budget in the amount of**  
10 **\$1,975,363.29"; and**

11 **WHEREAS, the FY 2016 Sif Oidak District Budget includes Gaming Revenues in the amount**  
12 **of \$1,615,811.13, Mining Royalties from FY09, FY11, FY13 in the amount of**  
13 **\$347,629.91, District Investments in the amount of \$11,922.25 for a total budget**  
14 **of \$1,975,363.29; and**

15 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**  
16 **have reviewed the said Budget and recommends approval.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**  
18 **hereby approve the FY 2016 Sif-Oidak District Budget in the amount of**  
19 **\$1,975,363.29 as attached.**

11 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
12 **16 of the Act of June 18, 1934 (48 Stat.984).**
