

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving SAWRSA Purchased Equipment Insurance Budget for Fiscal Year 2016)**

RESOLUTION NO. 15-385

1 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Legislative Council authorized**
2 **San Xavier Cooperative Association to perform maintenance for the completion**
3 **of the bank stabilization of the Santa Cruz River; and**

4 **WHEREAS, by Resolution No. 98-187, the Tohono O'odham Nation purchased equipment**
5 **and materials necessary for the project and the Nation assume financial**
6 **responsibility of the yearly insurance cost on such equipment; and**

7 **WHEREAS, pursuant to Section .309 (a) of the Southern Arizona Water Rights Settlement Act**
8 **of 1982 ("SAWRSA") the Tohono O'odham Nation (the "Nation") received**
9 **\$15,000,000.00 to be held in trust by the Nation (the "SAWRSA Trust Fund"); and**

10 **WHEREAS, under Section .309 (b) of SAWRSA, the Nation may expend accrued Interest and**
11 **dividends on the SAWRSA Trust Fund "for the subjugation of land, development**
12 **of water resources, and the construction, operation, maintenance, and the**
13 **replacement of related facilities on the Papago Reservation (now known as the**
14 **Tohono O'odham Reservation) which are not the obligation of the United States**
15 **under this (SAWRSA) or any other Act of Congress; and**

16 **WHEREAS, the San Xavier Cooperative Association has agreed to pay for the yearly**
17 **maintenance costs of the equipment and requests that the Nation pays for the**
18 **yearly insurances costs per resolution No 08-96; and**

19 **WHEREAS, the Equipment Insurance Budget qualify for the funding under the SAWRSA**
20 **Trust Fund; and**

21 **WHEREAS, the San Xavier District has prepared the attached budget for Fiscal Year 2016 in**
22 **the amount of \$3,422.00 and funded from the SAWRSA Trust Fund; and**

23 **WHEREAS, the Legislative Council Water Resources and Budget and Finance Committee**
24 **reviewed the Fiscal Year 2016 Budget Summary on August 14, 2015 and**
25 **recommended to move forward to Legislative Council.**

26 **NOW, THEREFORE, BE IT RESOLVED**

- 27 **1. The Tohono O'odham Legislative Council hereby approves the San Xavier**
28 **Cooperative Association Maintenance and Operational Equipment**
29 **Insurance Budget in the amount of \$3,422.00 for fiscal year 2016 in the**
30 **form attached hereto.**

1 2. **The Legislative Council appropriates the sum of \$3,422.00 from the**
2 **SAWRSA Trust Fund to fund the Equipment Insurance Budget for fiscal**
3 **year 2016.**

4 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes funding**
5 **from the SAWRSA Trust Fund to cover the yearly insurance costs on the**
6 **equipment.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND**
8 **day of SEPTEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4**
9 **FOR; -0- AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
10 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, the**
11 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
12 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
13 **16 of the Act of June 18, 1934 (48 Stat.984).**


