

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2015 Hia-Ced District Closeout Budget)

RESOLUTION NO. 15-386

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the authority to "manage any funds within the exclusive control of the**
3 **Tohono O'odham Nation..." and all "expenditures of these funds shall be**
4 **pursuant to appropriations or budgets authorized under resolutions or in**
5 **accordance with ordinances of the Tohono O'odham Council..." (Constitution,**
6 **Article VI, Section 1(d)(2)); and**

7 **WHEREAS, on February 2, 2015, the Legislative Council secretary received notice from the**
8 **Nation's Election Board that INT-01-14, entitled "Dissolution of the Hia Ced**
9 **District," was submitted to the office of the Board for verification and the Board**
10 **verified 389 registered voters signed the Initiative Petition; and**

11 **WHEREAS, pursuant to Article XV of the Constitution and Section 11309 of the Nation's**
12 **Elections law, the Legislative Council called an election to allow the Nation's**
13 **members to vote on the Initiative, and on April 25, 2015 a majority of Nation's**
14 **voters passed the Initiative and dissolved the Hia-Ced District (Legislative Order**
15 **No. 15-043); and**

16 **WHEREAS, with the dissolution of the Hia-Ced District, there are outstanding expenses and**
17 **forthcoming expenses that may be encountered for the duration of fiscal year**
18 **2015; and**

19 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed the**
20 **FY 2015 Hia-Ced District Closeout Budget, which includes operational expenses**
21 **only, and recommends its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
23 **approves the FY 2015 Hia-Ced District Closeout Budget in the amount of**
24 **\$36,295.00 from the FY 2015 General Fund Surplus.**

25 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it appropriates**
26 **\$36,295.00 from the FY 2015 General Fund Surplus for the FY 2015 Hia-Ced**
27 **District Closeout Budget.**


28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the**
29 **Nation's Chairperson and any designated official to expend and administer the**
30 **budget as attached, provided that any amendments affecting the funds or**

Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat.984).


