10	WHEREAS,	the Economic Development Delegation recommends that the Veridus firm be
11		retained as a governmental relations consultant for matters involving
12		legislative, administrative, lobbying, and agency activities in the State o
13		Arizona primarily related to the West Valley Resort, as well as related local and
14		municipal governmental activities that may affect the Nation in accordance with
15		the attached Governmental Relations Representation Contract with Veridus
16		("Contract") for the period commencing October 1, 2015 and ending September
17		30, 2016.
18	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
19		1. Approves the Contract with Veridus in the amount of \$240,000 for the period

- 1. Approves the Contract with Veridus in the amount of \$240,000 for the period commencing October 1, 2015 and ending September 30, 2016 in substantially the form attached hereto; provided that the Contract shall be funded from the FY 2016 Executive Branch Economic Development Delegation Budget; and
- 2. Authorizes the Nation's Chairperson to execute the Contract.
