9	WHEREAS,	the Legislative Council did adopt the Third Per Capita Revenue Allocation Plan					
10		pursuant to Legislative Council Resolution No. 06-307; and					
11	WHEREAS,	the Secretary of the Department of Interior did approve the Third Per Capita					
12		Revenue Allocation Plan on July 28, 2006; and					
13	WHEREAS,	the Tohono O'odham Membership Services submitted to the Tohono O'odham					
14		Legislative Council the Master List for Minor Eligible Members ("Master List") for					
15		review and approval for the third per capita distribution; and					
16	WHEREAS,	pursuant to Resolution No. 06-627, the Tohono O'odham Legislative Council					
17		approved the Master List and the approved number of verified eligible minor					
18		members for the third per capita distribution was 9,282; and					
19	WHEREAS,	the Enrollment Program has identified 2 eligible minor members who were left					
20		off the Master List for the third per capita payment; and					
21	WHEREAS,	the 2 minor members eligible for the third per capita payment did not have the					
22		Wells Fargo trust account established in accordance with the Wells Fargo Trust					
23		Agreement, which was approved by the Tohono O'odham Legislative Council					
24		Resolution No. 06-258; and					
25	WHEREAS,	the Nation's Treasurer has calculated the accrued interest due to the eligible					
26		minor members for the third per capita payment.					
27	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby;						
28		1. Approves the attached list of <u>2</u> eligible minor members whose names					
29		were left off the Master List for Minor Eligible Members for the Third Per					
30		Capita Distribution and such names will be incorporated into the Master					
31		List approved by Legislative Council Resolution No. 06-627.					
32		2. Authorizes the Office of the Treasurer to transfer \$4,000.00 from the					
33		Wells Fargo Third Per Capita Excess Funds Account to establish a trust					
34		account for each of the 2 minors at Wells Fargo Bank pursuant to the					
35		terms of the Trust Agreement approved by Tohono O'odham Legislative					
36		Council Resolution No. 06-258.

NOT VOTING; and <u>228.6 [07]</u> ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
