2		Federal Communications Commission (FCC) a construction permit to proceed
3		with the low power FM radio station for the community of Florence; and
4	WHEREAS,	the original construction permit issued on March 10, 2014, was extended from
5		September 10, 2015, through September 10, 2017, at the request of the Nation;
6		and
7	WHEREAS,	the extension provides additional time for the Nation to complete construction
8		of the KOHF-LP radio project (the Project) for which funds were appropriated by
9		Resolution No. 15-237, "Approving and authorizing an appropriation and
10		allocating general fund surplus for FY 2015 Florence KOHF-LP Radio Project
11		budget"; and
12	WHEREAS,	the appropriation's budget authority under Resolution No. 15-237 expires at the
13		end of fiscal year 2015, September 30, 2015, making it necessary to extend such
14		authority into fiscal year 2016 in order to complete the project within the
15		granted period; and
16	WHEREAS,	extending the budget authority for the project will require the Accounting
17		Department to carry-forward unexpended funds available under the fiscal year
18		2015 budget into the fiscal year 2016 budget; and
19	WHEREAS,	the Culture Preservation and the Budget and Finance Committees of the Tohono
20		O'odham Legislative Council have reviewed this resolution and recommend its
21		approval.
22	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends
23		Resolution No. 15-237, "Approving and authorizing an appropriation and
24		allocating general fund surplus for FY 2015 Florence KOHF-LP Radio Project
