

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Intergovernmental Agreement ADHS16-102341 with the Arizona
Department of Health Services for Public Health Emergency Preparedness
and Response)**

RESOLUTION NO. 15-400

1 **WHEREAS, the Arizona Department of Health Services is responsible for distributing**
2 **federal funds to Indian tribes in Arizona for public health preparedness and**
3 **response; and**

4 **WHEREAS, federal funds are appropriated by the Centers for Disease Control and**
5 **Prevention to the State of Arizona for allocation to the tribes in Arizona through**
6 **an Intergovernmental Agreement with the Arizona Department of Health**
7 **Services; and**

8 **WHEREAS, the funds appropriated by the Centers for Disease Control and Prevention are**
9 **dependent upon federal allocations and may vary in amounts and for which**
10 **funds allocated by the State to the tribes may in turn vary; and**

11 **WHEREAS, the Intergovernmental Agreement ADHS16-102341 is a fixed price agreement for**
12 **a period of five (5) years from July 1, 2015 to June 30, 2020; and**

13 **WHEREAS, the Tohono O'odham Nation has negotiated provisions in the special terms and**
14 **conditions of the Intergovernmental Agreement which preserves the Nation's**
15 **sovereign immunity from suit and restricts the application of state law on the**
16 **Nation's government; and**

17 **WHEREAS, the Centers for Disease Control award stipulates a 10% match requirement**
18 **which will be met through cost share of the Public Health Emergency**
19 **Preparedness Coordinator's salary with Community Health; and**

20 **WHEREAS, the Health and Human Services Committee and the Legislative Council have**
21 **reviewed this Intergovernmental Agreement and recommend its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 23 **1. Approves the Public Health Emergency Preparedness Intergovernmental**
24 **Agreement ADHS16-102341 with the Arizona Department of Health**
25 **Services as a fixed price contract for a period of five (5) years from July 1,**
26 **2015 to June 30, 2020.**
- 27 **2. Approves the 10% match requirement, which will be met through cost**
28 **share of the Public Health Preparedness Coordinator salary with**
29 **Community Health.**



3 **however, that any amendments affecting the IGA shall be submitted for**
4 **further prior approval by the Tohono O'odham Legislative Council.**

5 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
6 **day of OCTOBER, 2015 at a meeting at which a quorum was present with a vote of 2,572.9 FOR;**
7 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 448.5 [08] ABSENT, pursuant to the powers vested in the**
8 **Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted**
9 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
10 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
11 **the Act of June 18, 1934 (48 Stat.984).**
