

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting November 5, 2015 Special Session to Consider Appointment of Candidate**  
**to the Nation's Election Board and Approve Appointments to Nation's**  
**Enrollment Committee)**

**LEGISLATIVE ORDER NO. 15-401**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**  
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**  
3 **committees, boards and special committees." (Constitution of the Tohono**  
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**  
6 **Council with the authority to "by majority vote, call for a special session"**  
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**  
8 **1.D.1.); and**

9 **WHEREAS, the Rules Committee has requested a special session on November 5, 2015 to**  
10 **consider the appointment of a candidate to the Nation's Election Board and to**  
11 **approve appointments to the Nation's Enrollment Committee.**

12 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
13 **special session on November 5, 2015 to consider the appointment of a candidate**  
14 **to the Nation's Election Board and to approve appointments to the Nation's**  
15 **Enrollment Committee.**

16 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> day of**  
17 **OCTOBER, 2015 at a meeting at which a quorum was present with a vote of 2,572.9 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and 448.5[08] ABSENT, pursuant to the powers vested in the Council**  
19 **by Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
20 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
22 **June 18, 1934 (48 Stat.984).**
