

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2016 Sells District Administration Budget Amendment #1)**

**RESOLUTION NO. 15-405**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 15-325 approved the FY**  
2 **2016 District Allocation and Apportionment of Gaming Revenue to Districts by**  
3 **Equal Distribution in the amount of \$1,615,811.13 to each of the eleven Districts**  
4 **of the Tohono O'odham Nation; and**

5 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 15-383 did approve the**  
6 **FY2016 Sells District Budget in the amount of \$1,615,811.13; and**

7 **WHEREAS, Sells Community FY 2016 Budget of \$85,000 was not included in the Sells District**  
8 **FY 2016 Budget when it was presented to the Tohono O'odham Legislative**  
9 **Council; and**

10 **WHEREAS, Sells Community did prepare and now submits the approved Sells Community**  
11 **Budget in accordance to their needs in the amount of \$85,000; and**

12 **WHEREAS, the amount of \$85,000 Sells Community FY 2016 Budget will come out of the Sells**  
13 **District Administration FY 2016 Budget line item 7620 - Miscellaneous**  
14 **Assistance; and**

15 **WHEREAS, Sells District Council did review and approve to amend the FY 2016 Sells District**  
16 **Administration Budget to include Sells Community FY 2016 Budget of \$85,000**  
17 **with Sells District Resolution No. SD-97-15; and**

18 **WHEREAS, the Budget and Finance Committee of the Tohono O'odham Legislative Council**  
19 **did review Sells Community Budget for Sells District and recommends its**  
20 **approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
22 **Fiscal Year 2016 Sells District Administration Budget Amendment #1 to**  
23 **incorporate the FY 2016 Sells Community Budget and its justifications as**  
24 **submitted in the amount of \$85,000 to be taken from Sells District**  
25 **Administration Budget line item 7620 - Miscellaneous Assistance.**


26 **BE IT FURTHER RESOLVED that this does not change the overall approved budget in the**  
27 **amount of \$1,615,811.13.**

28 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
29 **Sells District Chairperson and any designated District Official to expend and**  
30 **administer the Budget according to its justification as attached, provided that**


any modifications/amendments affecting the funds or funding levels of the budget shall be submitted for further prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> day of OCTOBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).




