

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2016 Baboquivari District Budget Amendment #1)**

**RESOLUTION NO. 15-406**

1 **WHEREAS, Tohono O'odham Legislative Council enacted Resolution No. 15-374 "Approving**  
2 **FY 2016 Baboquivari District Budgets"; and**

3 **WHEREAS, \$201,423.45 was reserved for Topawa Community in Administration's budget in**  
4 **the Miscellaneous Line Item pending an approved budget; and**

5 **WHEREAS, Topawa Community has prepared a FY 2016 budget in the amount of \$247,636.08**  
6 **which includes FY 2016 Gaming Revenues in the amount of \$188,511.30, INT-01-**  
7 **14 Distribution of \$12,912.15, and FY2012 Carryover funds in the amount of**  
8 **\$46,212.63; and**

9 **WHEREAS, this amendment will increase the overall district budget from \$2,089,369.21 to a**  
10 **new overall budget in the amount of \$2,135,581.84; and**

11 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed the**  
12 **attached budgets and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
14 **approves FY 2016 Baboquivari District Budget Amendment #1 decreasing the**  
15 **Administration budget to \$201,423.45 and incorporating the FY2016 Topawa**  
16 **Community Budget in the amount of \$247,636.08 which includes FY 2016 Gaming**  
17 **Revenues in the amount of \$188,511.30, INT-01-14 Distribution of \$12,912.15,**  
18 **and FY2012 Carryover funds in the amount of \$46,212.63.**


19 **BE IT FURTHER RESOLVED that this will increase the overall district budget from \$2,089,369.21**

5 **O'odham Legislative Council.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>**  
7 **day of OCTOBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
8 **-0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
9 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
10 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
12 **June 18, 1934 (48 Stat.984).**
