

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY 2016 with the Law Firm of
Garvey Schubert Barer)

RESOLUTION NO. 15-410

1 **WHEREAS, the Office of Attorney General continues to require the legal services of the law**
2 **firm of Garvey Schubert Barer to represent the Tohono O'odham Nation in**
3 **matters involving the KOHN-FM radio station and the Federal Communications**
4 **Commission; and**

5 **WHEREAS, the Attorney General has recommended a budget of \$15,000.00 for FY 2016 for**
6 **the period from October 1, 2015 to September 30, 2016; and**

7 **WHEREAS, the funding for this Attorney Contract will come from the budget of the Office of**
8 **Attorney General; and**

9 **WHEREAS, the Domestic Affairs Committee has reviewed this attorney contract and**
10 **recommends approval by the Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 12 **1. The Tohono O'odham Legislative Council approves the Attorney Contract**
13 **with the law firm of Garvey Schubert Barer in the amount of \$15,000.00**
14 **for FY 2016, for the period from October 1, 2015 to September 30, 2016,**
15 **substantially in the form attached hereto.**
- 16 **2. Funding for the Attorney Contract shall be provided from the budget of**
17 **the Office of Attorney General.**
- 18 **3. The Chairperson of the Nation is authorized to execute the Attorney**
19 **Contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
21 **day of OCTOBER, 2015 at a meeting at which a quorum was present with a vote of 2,392.3 FOR;**
22 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 629.1[08] ABSENT, pursuant to the powers vested in the**
23 **Council by Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted**
24 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
25 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
26 **the Act of June 18, 1934 (48 Stat.984).**
