

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY2016 San Lucy District Budgets)

RESOLUTION NO. 15-415

1 **WHEREAS, Tohono O'odham Legislative Council enacted Resolution No. 15-325, "Approving**
2 **FY 2016 District Allocation and Apportionment of Gaming Revenue to Districts**
3 **by Equal Distribution"; and**

4 **WHEREAS, the apportionment for the San Lucy District is in the amount of \$1,615,811.13**
5 **and is made available for expenditure subject to an approved budget in**
6 **accordance with Article VI, Section 1(d)(2) and Article IX, Section 7 of the**
7 **Nation's Constitution; and**

8 **WHEREAS, San Lucy District requested a continuing resolution which was granted by**
9 **Tohono O'odham Legislative Council Resolution 15-380 pending an approved**
10 **budget; and**

11 **WHEREAS, San Lucy District prepared and approved FY 2016 Budgets for the District**
12 **Administration and its programs by District Resolution No. SL 10-104-15; and**

13 **WHEREAS, the District is also requesting their apportionment of the distribution of funds**
14 **from Resolution #15-275 passed by the Tohono O'odham Legislative Council**
15 ***"Implementing Initiative No. INT-01-14, "Dissolution of the Hia Ced District and***
16 ***Distributing Funds to Nation's District"* for an equal distribution to the Nation's**
17 **eleven Districts for an amount of \$126,260.07; and**

18 **WHEREAS, the FY 2016 budget will also include \$200,000.00 from Public Law 99-503; and**

19 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed the**
20 **attached Budgets and recommend its approval.**


21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
22 **approves FY 2016 San Lucy District budgets in the amount of \$1,942,071.20.**

23 **BE IT FURTHER RESOLVED that the FY 2016 budgets include \$1,615,811.13 of gaming revenues;**
24 **\$126,260.07 from INT-01-14 Distribution and \$200,000.00 from PL 99-503.**


25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
26 **District Chairperson and any designated official to expend and administer the**
27 **Budget as attached, provided that any Modifications/Amendments affecting the**
28 **funds or funding level is submitted for further prior approval by the Tohono**
29 **O'odham Legislative Council.**

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH
2 day of OCTOBER, 2015 at a meeting at which a quorum was present with a vote of 3,021,4 FOR;
3 -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
4 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
5 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
7 June 18, 1934 (48 Stat.984).


