

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Ida Norris to the Enrollment Committee)**

RESOLUTION NO. 15-416

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers**
3 **of committees, boards, officers and agents" (Article VI, Section 1(b) of the**
4 **Constitution of the Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has enacted and subsequently amended Ordinance No.**
6 **05-81, the "Enrollment Ordinance," which establishes an Enrollment Committee**
7 **to oversee enrollment into memberships in the Tohono O'odham Nation; and**

8 **WHEREAS, the Enrollment Ordinance provides that the Enrollment Committee "shall be**
9 **composed of five members of the Tohono O'odham Nation who are bilingual in**
10 **the O'odham and English languages" and whose members "shall be appointed**
11 **by the Chairman of the Nation, subject to the approval of the Tohono O'odham**
12 **Legislative Council" (14 T.O.C. Chapter 1, Article II, Section 1(A) and 1(B)); and**

13 **WHEREAS, Committee members "shall be appointed for a five-year term, but shall continue**
14 **to serve until the member's successor is appointed. Vacancies shall be filled for**
15 **the unexpired term of that seat on the Committee and appointments shall be**
16 **staggered so that no more than two members' terms shall expire in the same**
17 **year." (14 T.O.C. Chapter 1, Article II, Section 1(C)); and**

18 **WHEREAS, subject to the approval by the Legislative Council, the Chairman of the Tohono**
19 **O'odham Nation has appointed Ms. Ida Norris to the Enrollment Committee to**
20 **fill a vacant seat; and**


21 **WHEREAS, if approved, Ida Norris would serve on the Enrollment Committee until January**
22 **1, 2021; provided that she would continue to serve until replaced by a successor**
23 **who is appointed in accordance with the Enrollment Ordinance.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **appointment of Ida Norris to the Enrollment Committee upon the effective date**
26 **of this resolution; notwithstanding 14 T.O.C. Chapter 1, Article II, Section 1(C),**
27 **Ms. Norris's term shall expire on January 1, 2021, provided that she shall**
28 **continue to serve until her successor has been appointed in accordance with the**
29 **Enrollment Ordinance.**






