

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Clarence Miguel to the Enrollment Committee)

RESOLUTION NO. 15-418

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers**
3 **of committees, boards, officers and agents" (Article VI, Section 1(b) of the**
4 **Constitution of the Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has enacted and subsequently amended Ordinance No.**
6 **05-81, the "Enrollment Ordinance," which establishes an Enrollment Committee**
7 **to oversee enrollment into memberships in the Tohono O'odham Nation; and**

8 **WHEREAS, the Enrollment Ordinance provides that the Enrollment Committee "shall be**
9 **composed of five members of the Tohono O'odham Nation who are bilingual in**
10 **the O'odham and English languages" and whose members "shall be appointed**
11 **by the Chairman of the Nation, subject to the approval of the Tohono O'odham**
12 **Legislative Council" (14 T.O.C. Chapter 1, Article II, Section 1(A) and 1(B)); and**

13 **WHEREAS, Committee members "shall be appointed for a five-year term, but shall continue**
14 **to serve until the member's successor is appointed. Vacancies shall be filled for**
15 **the unexpired term of that seat on the Committee and appointments shall be**
16 **staggered so that no more than two members' terms shall expire in the same**
17 **year." (14 T.O.C. Chapter 1, Article II, Section 1(C)); and**

18 **WHEREAS, Clarence Miguel was appointed by Resolution No. 08-464 to a five-year term on**
19 **the Enrollment Committee with a term ending January 1, 2010 but continues to**
20 **serve until his successor is appointed; and**

21 **WHEREAS, subject to the approval by the Legislative Council, the Chairman of the Tohono**
22 **O'odham Nation has appointed Mr. Clarence Miguel to the Enrollment**
23 **Committee; and**


24 **WHEREAS, if approved, Clarence Miguel would serve on the Enrollment Committee until**
25 **January 1, 2020; provided that he would continue to serve until replaced by a**
26 **successor who is appointed in accordance with the Enrollment Ordinance.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
28 **appointment of Clarence Miguel to the Enrollment Committee upon the**
29 **effective date of this resolution; notwithstanding 14 T.O.C. Chapter 1, Article II,**
30 **Section 1(C), Mr. Miguel's term shall expire on January 1, 2020, provided that he**


shall continue to serve until his successor has been appointed in accordance with the Enrollment Ordinance.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 2,170.8 FOR; 850.6 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(b) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
