

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Matilda S. Juan to the Election Board for a Five-Year Term  
Ending July 31, 2020)**

**RESOLUTION NO. 15-419**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the powers to provide for,**  
2 **appoint, or provide for the appointment of, and prescribe the duties and powers**  
3 **of committees, boards, officers and agents" (Article VI, Section 1(b) of the**  
4 **Constitution of the Tohono O'odham Nation); and**

5 **WHEREAS, the Nation's Elections law, codified at 12 Tohono O'odham Code, Chapter 1,**  
6 **authorizes the Tohono O'odham Legislative Council to appoint members of the**  
7 **Tohono O'odham Election Board (12 T.O.C. Chapter 1, Article III, Section**  
8 **1301(B)); and**

9 **WHEREAS, the Nation's Elections law provides that board members shall be**  
10 **"appointed...for a term of five years or until their successors are appointed" and**  
11 **further that "[a]ppointments to the Board shall be staggered so that the term of**  
12 **office of only one member will end in any single year." (12 T.O.C. Chapter 1,**  
13 **Article III, Section 1301(B)); and**

14 **WHEREAS, Matilda S. Juan was appointed to the Election board by Resolution No. 10-449 for**  
15 **a term ending July 31, 2015 and she continues to serve until her successor is**  
16 **appointed; and**

17 **WHEREAS, the Rules Committee recommends that Matilda S. Juan be appointed to the**  
18 **Election Board for a term ending July 31, 2020.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **appointment of Matilda S. Juan to the Election Board beginning on the effective**  
21 **date of this resolution and ending July 31, 2020; provided that she shall continue**  
22 **to serve until replaced by a successor who has been appointed and qualified.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
24 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 1,561.0 FOR;**  
25 **1,460.4 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**  
26 **Council by Article VI, Section 1(b); Article X, Section 7 of the Constitution of the Tohono**  
27 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
28 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
29 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
