

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY 2016 with the Law Firm of Dentons US LLP)**

RESOLUTION NO. 15-423

1 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of**
2 **Dentons US LLP to represent the Tohono O'odham Nation in matters relating to**
3 **the West Valley Resort project; and**

4 **WHEREAS, the Attorney General has recommended an attorney contract with Dentons US**
5 **LLP for FY 2016 for the period from October 1, 2015 to September 30, 2016; and**

6 **WHEREAS, the funding for this Attorney Contract will come from sources approved for such**
7 **purposes by the Legislative Council; and**

8 **WHEREAS, the Domestic Affairs Committee has reviewed this attorney contract and**
9 **recommends approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 1. **The Tohono O'odham Legislative Council approves the Attorney Contract**
12 **with the law firm of Dentons US LLP for FY 2016, for the period of October**
13 **1, 2015 to September 30, 2016, substantially in the form attached hereto**
- 14 2. **Funding for the Attorney Contract will come from sources approved for**
15 **such purposes by the Legislative Council.**
- 16 3. **The Chairperson of the Nation is authorized to execute the Attorney**
17 **Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
19 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
20 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
21 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
24 **June 18, 1934 (48 Stat.984).**
