

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Attorney Contract for FY 2016 with Edward Johnson)**

**RESOLUTION NO. 15-424**

1 **WHEREAS, the Office of Attorney General continues to require the legal services of Edward**  
2 **Johnson to represent the Tohono O'odham Nation in legal proceedings in**  
3 **Maricopa County, Arizona, involving the Nation's interests under the Indian**  
4 **Child Welfare Act; and**

5 **WHEREAS, the Attorney General recommends an Attorney Contract with Edward Johnson in**  
6 **the amount of \$35,000.00 for fiscal year 2016, for the period October 1, 2015 to**  
7 **September 30, 2016; and**

8 **WHEREAS, the Domestic Affairs Committee has reviewed the attorney contract and**  
9 **recommends approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract**  
12 **with Edward Johnson in the amount of \$35,000.00 for fiscal year 2016, for**  
13 **the period of October 1, 2015 to September 30, 2016, substantially in the**  
14 **form attached hereto.**
- 15 **2. Funding for the Attorney Contract shall be from the budget of the Office**  
16 **of Attorney General.**
- 17 **3. The Chairperson of the Nation is authorized to execute the Attorney**  
18 **Contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
20 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
21 **-0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
22 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
25 **June 18, 1934 (48 Stat.984).**
