

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Attorney Contract for FY 2016 with the Lenihan Law Firm)**

**RESOLUTION NO. 15-426**

1 **WHEREAS, the Office of Attorney General requires the legal services of the Lenihan Law**  
2 **Firm to represent the Tohono O'odham Nation in matters relating to the**  
3 **acquisition of patented mining claims; and**

4 **WHEREAS, the Attorney General has recommended a budget of \$20,000.00 for the period**  
5 **from October 1, 2015 to September 30, 2016; and**

6 **WHEREAS, the funding for this Attorney Contract will come from the Land Acquisition Fund;**  
7 **and**

8 **WHEREAS, the Agricultural and Natural Resources and Domestic Affairs Committees have**  
9 **reviewed this attorney contract and recommend approval by the Legislative**  
10 **Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that:**

- 12 **1. The Tohono O'odham Legislative Council approves the Attorney Contract**  
13 **with the Lenihan Law Firm in the amount of \$20,000.00 for FY 2016, for**  
14 **the period from October 1, 2015 to September 30, 2016, substantially in**  
15 **the form attached hereto.**
- 16 **2. Funding for the Attorney Contract will come from the Land Acquisition**  
17 **Fund.**
- 18 **3. The Chairperson of the Nation is authorized to execute the Attorney**  
19 **Contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
21 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
22 **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
23 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
26 **June 18, 1934 (48 Stat.984).**
