

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY 2016 with Sonosky, Chambers, Sachse,
Miller and Munson, LLP)

RESOLUTION NO. 15-427

1 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of**
2 **Sonosky, Chambers, Sachse, Miller & Munson, LLP, to represent the Tohono**
3 **O'odham Nation in legal proceedings arising from the Nation's Public Law 93-**
4 **638 contract with the Indian Health Service; and**

5 **WHEREAS, the Attorney General has proposed an attorney contract with Sonosky,**
6 **Chambers, Sachse, Miller & Munson, LLP, for fiscal year 2016, for the period**
7 **from October 1, 2015 to September 30, 2016, in the amount of \$185,000.00; and**

8 **WHEREAS, the Domestic Affairs Committee has reviewed the attorney contract and**
9 **recommends approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council approves an attorney contract**
12 **with Sonosky, Chambers, Sachse, Miller & Munson, LLP in the amount of**
13 **\$185,000.00 for fiscal year 2016, for the period from October 1, 2015 to**
14 **September 30, 2016, substantially in the form attached hereto.**
- 15 **2. Funding for the attorney contract shall be provided from the operating**
16 **budget of the Office of Attorney General.**
- 17 **3. The Chairperson of the Nation is authorized to execute the attorney**
18 **contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
20 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
21 **-0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
25 **June 18, 1934 (48 Stat.984).**
