

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY2016 with Steven Weatherspoon PLLC)**

RESOLUTION NO. 15-428

1 **WHEREAS, the Office of Attorney General continues to require the legal services of Steven**
2 **Weatherspoon to assist the Tohono O'odham Nation with respect to matters**
3 **relating to the Nation's water, including implementation of the Nation's Water**
4 **Code, implementation of SAWRSA, water settlements, and other related matters**
5 **as assigned by the Attorney General; and**

6 **WHEREAS, funding for the attorney contract will be from the SAWRSA Trust Fund; and**

7 **WHEREAS, the Domestic Affairs and Water Resources Committees have reviewed the**
8 **attorney contract and recommend approval by the Legislative Council.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 10 **1. Approves the Attorney Contract with Steven Weatherspoon, PLLC, in the**
11 **amount of \$150,000.00 for the period October 1, 2015 to September 30,**
12 **2016, substantially in the form attached hereto;**
13 **2. Funding for the Attorney Contract shall be from the SAWRSA trust fund;**
14 **3. The Chairperson of the Nation is authorized to execute the Attorney**
15 **Contract.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
17 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
18 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
19 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
20 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
22 **June 18, 1934 (48 Stat.984).**
