1 **WHEREAS, the Office of Attorney General requires the legal services of the Wilmer Cutler**
2 **Pickering Hale and Dorr, LLP law firm ("Wilmer Hale") to represent the Tohono**
3 **O'odham Nation in matters relating to the West Valley Resort project; and**

4 **WHEREAS, the Attorney General has recommended an attorney contract for fiscal year 2016**
5 **for the period from October 1, 2015 to September 30, 2016; and**

6 **WHEREAS, the funding for this Attorney Contract will come from sources approved for such**
7 **purposes by the Legislative Council; and**

8 **WHEREAS, the Domestic Affairs Committee has reviewed this attorney contract and**
9 **recommends approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract**
12 **with the Wilmer Hale law firm for fiscal year 2016, for the period from**
13 **October 1, 2015 to September 30, 2016, substantially in the form attached**
14 **hereto.**
- 15 **2. Funding for the Attorney Contract will come from sources approved for**
16 **such purposes by the Legislative Council.**
- 17 **3. The Chairperson of the Nation is authorized to execute the Attorney**
18 **Contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
20 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
21 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
25 **June 18, 1934 (48 Stat.984).**
