1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, the Enrollment Program has determined that a number of resolutions**
11 **approving applicants for membership contain misspellings in the names of**
12 **applicants; or incorrect roll numbers; and**

13 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 97-480, 98-**
14 **034, 98-174, 98-492, 99-039, 99-200, 99-475, 99-633, 2000-397, 01-004, 01-094, 01-**
15 **355, 01-449, 01-589, 02-241 and 10-153 be amended to reflect the correct name**
16 **spelling and/or roll numbers for the individuals identified in the Amending**
17 **Enrollment Resolution List November 2015, which is incorporated by this**
18 **reference.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
20 **Resolution Nos. 97-480, 98-034, 98-174, 98-492, 99-039, 99-200, 99-475, 99-633,**
21 **2000-397, 01-004, 01-094, 01-355, 01-449, 01-589, 02-241 and 10-153 are amended**
22 **upon the effective date of those resolutions to reflect the corrected names or roll**
23 **numbers identified in the Amending Enrollment Resolution List November**
24 **2015.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
26 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
29 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
30 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
31 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


