

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Kupk/Dirtburn Community FY 2016 Budget Amendment #1)**

RESOLUTION NO. 15-439

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 15-325 approved the FY**
2 **2016 District Allocation and Apportionment of Gaming Revenue to Districts by**
3 **Equal Distribution in the amount of \$1,615,811.13 to each of the eleven Districts**
4 **of the Tohono O'odham Nation; and**

5 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 15-378 did approve the**
6 **FY2016 Pisinemo District Budget in the amount of \$1,615,811.13; and**

7 **WHEREAS, Pisinemo District Council by Resolution 16-P-07 approved budget amendment**
8 **#1 for the Kupk/Dirtburn Community; and**

9 **WHEREAS, the amendment #1 will change the justification for line item 854 Clothing**
10 **Allowance; and**

11 **WHEREAS, the amendments were made to correctly list the amounts and wording**
12 **requested by the Kupk/Dirtburn Community and does not change the original**
13 **base amount of \$24,500.00 for Kupk/Dirtburn Community; and**

14 **WHEREAS, the Budget and Finance Committee has reviewed the attached budget and**
15 **recommends its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
17 **approves the Kupk/Dirtburn Community FY 2016 Budget Amendment #1.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
19 **the District Chairperson and any designated official to expend and administer**
20 **the budget as attached provided that any amendments/modifications affecting**
21 **the funds or funding levels of the budget shall, be submitted to the Tohono**
22 **O'odham Legislative Council for further prior approval**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
24 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 2,840.8 FOR;**
25 **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and 180.6 [03] ABSENT, pursuant to the powers vested in the**
26 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,**
27 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
28 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
29 **16 of the Act of June 18, 1934 (48 Stat.984).**
