

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Santa Cruz Community FY 2016 Budget Amendment #1)**

**RESOLUTION NO. 15-440**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 15-325 approved the FY**  
2 **2016 District Allocation and Apportionment of Gaming Revenue to Districts by**  
3 **Equal Distribution in the amount of \$1,615,811.13 to each of the eleven Districts**  
4 **of the Tohono O'odham Nation; and**

5 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 15-378 did approve the**  
6 **FY2016 Pisinemo District Budget in the amount of \$1,615,811.13; and**

7 **WHEREAS, Pisinemo District Council by Resolution 16-P-06 approved budget amendment**  
8 **#1 for the Santa Cruz Community; and**

9 **WHEREAS, the amendment #1 will change the justification for line item 810 Professional**  
10 **Services, 812 Public Relations, 852 Donations and Contributions, 854 Clothing**  
11 **Allowance; and**

12 **WHEREAS, amendment #1 will also include addition of new line items 7015 Uniforms, 7620**  
13 **Miscellaneous; and**

14 **WHEREAS, the amendments were made to correctly list the amounts and wording**  
15 **requested by the Santa Cruz Community and does not change the original base**  
16 **amount of \$24,500.00 for Santa Cruz Community; and**

17 **WHEREAS, the Budget and Finance Committee has reviewed the attached budget and**  
18 **recommends its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
20 **approves the Santa Cruz Community FY 2016 Budget Amendment #1.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
22 **the District Chairperson and any designated official to expend and administer**  
23 **the budget as attached provided that any amendments/modifications affecting**  
24 **the funds or funding levels of the budget shall be submitted to the Tohono**  
25 **O'odham Legislative Council for further prior approval**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
27 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
28 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
32 **June 18, 1934 (48 Stat.984).**
