

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District Fiscal Year 2016 Tower User Fees (2nd & 3rd Quarters)
Budget in the amount of \$53,744.30)

RESOLUTION NO. 15-442

1 **WHEREAS, the Tohono O'odham Legislative Council approved a Management Agreement**
2 **between the Tohono O'odham Nation, Gu Achi District and the Tohono O'odham**
3 **Utility Authority (TOUA) for Jewek Mountain (Resolution #08-586) which allowed**
4 **the Nation and Gu Achi District to obtain a stream of revenue from TOUA's**
5 **leasing space on the transmission tower and the associated equipment building;**
6 **and**

7 **WHEREAS, the Management Agreement was revised and approved by the Legislative**
8 **Council (Resolution #14-412) superseding Resolution #08-586; and**

9 **WHEREAS, on October 24, 2015, the Gu Achi District Council approved Resolution #1015-072**
10 **for a budget in the amount of \$53,744.30 from the revenue of the tower user fees**
11 **for the following budget line item:**

15 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did**
16 **review the Fiscal Year 2016 Tower User Fees budget and recommend its**
17 **approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
19 **approve the Gu Achi District's Fiscal Year 2016 Tower User Fees (2nd & 3rd**
20 **Quarters) Budget in the amount of \$53,744.30 as attached hereto.**

21 **BE IT FINALLY RESOLVED the Tohono O'odham Legislative Council hereby authorizes the**
22 **District Chairperson and any designated official to expend and administer the**
23 **Budget as attached, provided that any modifications/amendments affecting the**
24 **funds or funding level is submitted for further prior approval by the Tohono**
25 **O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
27 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 2,840.8**
28 **FOR; -0- AGAINST; -0- NOT VOTING; and 180.6 [03] ABSENT, pursuant to the powers vested in the**
29 **Council by Article VI, Section 1(h) and (i) of the Constitution of the Tohono O'odham Nation,**
30 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**




