

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

RESOLUTION NO. 15-443

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that" (a)All**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution ordinance (*Constitution of the Tohono O'odham***
6 ***Nation, Article VI, Section 1(d)(2)*); and**

7 **WHEREAS, on November 10, 2015, the Gu Achi District Council approved a budget**
8 **amendment for Cababi Community budget line items #7060 – FOOD and #7100 -**
9 **UTILITIES; and**

10 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did**
11 **review the budget amendment for Cababi Community submitted by the Gu Achi**
12 **District and recommend for approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
14 **approve the Gu Achi District's Fiscal Year 2016 Budget Amendment #1 for Cababi**
15 **Community as listed.**

31 **Chairperson and any designated official to expend and administer the budget as**
32 **attached, provided that any amendments affecting the funds or funding level is**
33 **submitted for further prior approval by the Tohono O'odham Legislative**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 2,840.8 FOR; -0- AGAINST; -0- NOT VOTING; and 180.6 [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
