

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Ske:g Hihiosig/Beautiful Flowers Elder Garden Project Budget Amendment #1)

RESOLUTION NO. 15-447

1 **WHEREAS, the Tohono O'odham Nation submitted an application for funding to the**
2 **Freeport McMoran Copper & Gold Foundation under the Native American**
3 **Partnership Fund for the Ske:g Hihiosig/Beautiful Flowers Elder Garden Project**
4 **and was awarded the amount of \$50,000.00 for creation of an outdoor gathering**
5 **area and garden for Elders at the Tohono O'odham Department of Health and**
6 **Human Services complex for Elders to 1) engage in cultural activities to promote**
7 **wellbeing and cultural exchange and 2) participate in health promotion through**
8 **the Elder Nutrition program; and**

9 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 15-138 approved the FY2016**
10 **Budget for the Ske:g Hihiosig/Beautiful Flowers Elder Garden Project; and**

11 **WHEREAS, the budget has been amended to increase the funds for 7355 – Professional**
12 **Services; utilizing funds from 7430 – RM Grounds and 9000 – Indirect Direct**
13 **Costs line items; and**

14 **WHEREAS, the additional funds for Professional Services is needed to process final**
15 **payment for all phases of the completed construction of the Ramada for elders;**
16 **and**

17 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
18 **Legislative Council have reviewed the budget and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
20 **approves the FY2016 Ske:g Hihiosig/Beautiful Flowers Elder Garden Project**
21 **Budget Amendment #1 that reflects the increase of funds for Professional**
22 **Services to process final payment for all phases of the completed construction of**
23 **the Ramada for elders.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **Chairperson and any designated official to expend and administer the budget as**
26 **attached, provided that any Amendments affecting the funds or funding level is**
27 **submitted for further prior approval by the Tohono O'odham Legislative**
28 **Council.**
