

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Department of Health & Human Services -
Community Health Budget Amendment #1)

RESOLUTION NO. 15-448

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from**
2 **the Indian Health Service; and**

3 **WHEREAS, the Legislative Council approved and accepted by Resolution #15-168, the FY**
4 **2016 TODHHS/IHS Budgets to be effective October 1, 2015 through September 30,**
5 **2016; and**

6 **WHEREAS, the Community Health budget amendment has been prepared and submitted to**
7 **utilize carry forward funds from FY 2015, for approval to create new line items**
8 **8040 Site Preparation and 8050 Construction Utilities and increasing 7500 Major**
9 **Capital to fund a new modular structure needed for the Home Health Program**
10 **and increasing Indirect Cost and the total budget amount from \$3,231,743.00 to**
11 **\$3,423,784.00; and**

12 **WHEREAS, the Health and Human Service and the Budget and Finance Committees of the**
13 **Legislative Council have reviewed this budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **approves the Community Health budget amendment #1:**

- 16 **1. Approve the usage of carry forward funds from FY 2015 and increase in**
17 **capital expenses for a new modular structure to house the Home Health**
18 **Program staff.**
- 19 **2. Approve the addition of line items 8040 Site Preparation and 8050**
20 **Construction Utilities.**
- 21 **3. Approve the increase of Indirect Cost to \$498,136.21 and the budget**
22 **amount to \$3,423,784.00.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairman and any designated official to expend and administer the budget, as**
25 **attached, provided that any amendments affecting the funds or funding level is**
26 **submitted for further prior approval by the Tohono O'odham Legislative**
27 **Council.**
