

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family
Assistance - FY 2016 Food Distribution Program Budget Amendment #1)**

RESOLUTION NO. 15-449

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY 2016 grant with the**
3 **United States Department of Agriculture (USDA); and**

4 **WHEREAS, by Resolution #15-180, the Tohono O'odham Legislative Council approved the**
5 **FY2016 USDA Food Distribution budget in the amount of \$244,714.00; and**

6 **WHEREAS, the Nation was notified of a final USDA grant award in the amount of \$244,715.00**
7 **and since there is a need to reduce the cost share of the administrative assistant**
8 **position, as well as increase/reduce line items and add new line items for 7100-**
9 **Utilities and 7110-Communications to match our funding request, the Division**
10 **of Family Assistance has prepared the attached budget to reflect these changes;**
11 **and**

12 **WHEREAS, the Health and Human Service and the Budget and Finance Committees of the**
13 **Legislative Council have reviewed this budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
15 **and authorizes the FY2016 Food Distribution Program budget amendment #1, in**
16 **the amount of \$244,715.00 in accordance with the attached budget and add new**
17 **line items for 7100-Utilities and 7110-Communications and to utilize the**
18 **Nation's resources pending reimbursement from the Grantor for the**
19 **continuation of this Grant.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairperson and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding level**
23 **shall be submitted for further prior approval by the Tohono O'odham**
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**
26 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2)(3)&(f) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
31 **June 18, 1934 (48 Stat.984).**
