1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2016 grant with the**
3 **United States Department of Agriculture (USDA); and**

4 **WHEREAS, the Food Distribution Program has been beneficial in providing food packages**
5 **(commodity foods) and nutrition education to eligible households through**
6 **tailgate distribution system throughout the Nation and nearby towns; and**

7 **WHEREAS, by Resolution Number 15-165 the Tohono O'odham Legislative Council approved**
8 **the FY2016 Food Distribution Program, Nutrition Education budget in the**
9 **amount of \$1,910.00; and**

10 **WHEREAS, the Tohono O'odham Nation was notified of the final grant award for the FY2016**
11 **USDA Food Distribution Program, Nutrition Education budget in the amount of**
12 **\$2,300.00 an increase of \$390.00; and**

13 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family**
14 **Assistance Division, Food Distribution Program has prepared the attached**
15 **FY2016 Nutrition Education Budget Amendment #1 which increases line items**
16 **and Indirect Cost; and**

17 **WHEREAS, the Health and Human Service and the Budget and Finance committees have**
18 **reviewed Budget Amendment #1 and recommend its approval.**

19 **NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **Department of Health and Human Services, Division of Family Assistance -**
21 **FY2016 USDA Food Distribution Program Nutrition Education Budget**
22 **Amendment #1 as attached.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding level**
26 **shall be submitted for further prior approval by the Tohono O'odham**
27 **Legislative Council.**
