

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Department of Health and Human Services, Division of Family Assistance - FY2016 Tribal Food Distribution Program Budget Amendment #1)**

**RESOLUTION NO. 15-451**

1 **WHEREAS, by Resolution Number 15-165 the Tohono O'odham Legislative Council approved**  
2 **the FY2016 Food Distribution Program Tribal budget in the amount of**  
3 **\$84,009.00; and**

4 **WHEREAS, the Nation was notified of the final grant award for the Food Distribution**  
5 **Program USDA budget, which funding requirement is at a 75% match by USDA**  
6 **and a 25% match by Tribal funds; and**

7 **WHEREAS, the Department of Health and Human Services, Family Assistance Division has**  
8 **prepared the attached Tribal Food Distribution Program Budget Amendment #1**  
9 **which increases 6000 Salaries and Fringes; and**

10 **WHEREAS, the FY16 Tribal Food Distribution budget amount has increased from \$84,009.00**  
11 **to \$119,136.42; an increase of \$35,127.42; and**

12 **WHEREAS, the Health and Human Service and the Budget and Finance committees have**  
13 **reviewed this Budget Amendment #1 and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
15 **approve the FY 2016 Tribal Food Distribution Program Budget Amendment #1 as**  
16 **attached.**

17 **BE IT FURTHER RESOLVED that Amendment #1 will increase the budget from \$84,009.00 to**  
18 **\$119,136.42; an increase of \$35,127.42 to be appropriated from the General Fund**  
19 **Surplus.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
21 **Chairperson and any designated official to expend and administer the budget as**  
22 **attached, provided that any amendments affecting the funds or funding level**  
23 **shall be submitted for further prior approval by the Tohono O'odham**  
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>**  
26 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
27 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article VI, Section 1(d)(2)(3)&(f) of the Constitution of the Tohono O'odham Nation, adopted by**  
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
31 **June 18, 1934 (48 Stat.984).**




