

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Self-Governance Project Funding Budget in the amount of \$261,799.00)

RESOLUTION NO. 15-453

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 15-365 authorized the**
2 **assumption of remaining federal programs, functions, services and activities**
3 **carried out by the Indian Health Services; and**

4 **WHEREAS, the budget, in the amount of \$261,799.00, has been created to utilize funds from**
5 **the settlement agreement from Indian Health Service for prior contract support**
6 **funding short fall and authorized by Resolution No. 15-364; and**

7 **WHEREAS, the majority of the funding will be utilized for professional contractual services**
8 **needed for expert assistance and guidance for processing all phases of the**
9 **proposed project completion which is to assume all programs, functions,**
10 **services and activities currently performed by the Indian Health Service for the**
11 **benefit of the Nation; and**

12 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
13 **Legislative Council have reviewed the budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
15 **approves the submitted FY2016 budget, in the amount of \$261,799.00, for self-**
16 **governance project funding for period from October 1, 2015 to September 30,**
17 **2016.**


18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the budget as**
20 **attached, provided that any Amendments affecting the funds or funding level is**
21 **submitted for further prior approval by the Tohono O'odham Legislative**
22 **Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**
24 **day of NOVEMBER, 2015 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
25 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
29 **June 18, 1934 (48 Stat.984).**


