

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Chester Antone to Serve as a Delegate From the Tucson
Area on the Centers for Disease Control and Prevention/Agency for Toxic Substances
and Disease Registry ("CDC/ATSDR") Tribal Advisory Committee ("TAC")
and Designates Representative Sandra Ortega as Alternate)**

RESOLUTION NO. 15-457

1 **WHEREAS, the Legislative Council is vested with the authority to "consult with the Congress**
2 **of the United States and appropriate federal agencies regarding federal**
3 **activities that affect the Tohono O'odham Nation. . ." and "to promote, protect**
4 **and provide for public health, peace, morals, education and general welfare of**
5 **the Tohono O'odham Nation and its members. . ." (Constitution, Article VI,**
6 **Section 1(j) and Section 1(c)(2)); and**

7 **WHEREAS, the Centers for Disease Control and Prevention ("CDC") and Agency for Toxic**
8 **Substances and Disease Registry ("ATSDR") recognize their special commitment**
9 **and unique relationship with Indian tribes and are committed to fulfilling their**
10 **missions to promote the health and quality of life by preventing disease, injury,**
11 **and disability through established and ongoing relationships and consultation**
12 **sessions; and**

13 **WHEREAS, in 2005, CDC and ATSDR established the Tribal Advisory Committee ("TAC"),**
14 **which serves as an advisory committee to CDC and ATSDR and provides input**
15 **and guidance on policies, guidelines, and programmatic issues affecting the**
16 **health of Indian tribes; and**

17 **WHEREAS, the TAC is composed of 16 delegates: one delegate (and one authorized**
18 **representative) from each of the 12 Indian Health Service ("IHS") areas and one**
19 **delegate (and one authorized representative) from four federally-recognized**
20 **tribes at-large; and**

21 **WHEREAS, the Health and Human Services Committee recommends the nomination of**
22 **Representative Chester Antone to serve as a delegate from the Tucson Area on**
23 **the Centers for Disease Control and Prevention/Agency for Toxic Substances and**
24 **Disease Registry Tribal Advisory Committee; and**

25 **WHEREAS, the Health and Human Services Committee designates Representative Sandra**
26 **Ortega to serve as Representative Chester Antone's alternate.**

8 **pursuant to this resolution shall supersede any prior nominations and**
9 **appointments to the Centers for Disease Control and Prevention/Agency for**
10 **Toxic Substances and Disease Registry Tribal Advisory Committee** and
11 **appointments made pursuant to this resolution shall immediately expire if the**
12 **appointments representatives no longer serve on the Health and Human**
13 **Services Committee for any reason.**


14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**


